MEASUREMENT OF OUTCOMES

As an organization committed to promoting responsible practices and advancing the principles of the United Nations Global Compact (UNGC), CAPSC actively supports initiatives that align with the UNGC's Ten Principles.

- 1. Participation and Engagement: Measure the attendance and level of engagement at each event, including the number of participants, feedback received, and social media interactions. This will indicate the reach and impact of CAPSC's activities in supporting the UN Global Compact principles and fostering community involvement.
- 2.
