as the chambers of the region.

For the 3rd topic "Businesses should uphold the freedom of union members and the

effective recognition of the right to collective bargaining ", ICSD organized one

meeting and participated in two meetings organized by the collective bodies.

For the fourth authority "Businesses should uphold the elimination of all forms of

forced or compulsory labor", ICSD organized and hosted two online workshops.

For the 5th topic "Businesses should uphold the effective abolition of child labor" the

ICSD organized informative meeting with the participation of schools in the region.

For the 6th principle "Businesses should uphold the elimination of discrimination in

respect of employment and occupation ", the ICSD participated in one workshop

organized by civil society.

For the seventh principle "Businesses should support a precautionary approach to

environmental challenges ICSD, runs a nationally project with schools of Arta's

region about recycling.

environmental responsibility", the ICSD has an Erasmus+ project "Our city our
