WORK IN PROGRESS

Our organization is fully committed with the Agenda 2023 and the Global Development Goals, since we joined the Global Pact in 2022.

First of all, we are a small and single-person non-profit organization focused on educational training in the Canary Islands and on international cooperation (Equatorial Guinea) in the field of health.

Secondly, this report addresses the following issues and principles:

- HUMAN RIGHTS
 - Principle 1 Businesses should support and respect the protection of internationally proclaimed human rights; and
 - Principle 2 make sure that they are not complicit in human rights abuses.
- LABOUR
 - Principle 3 Businesses should uphold the freedom of association and the effective recognition of the right to collective bargaining;
 - Principle 4 the elimination of all forms of forced and compulsory labour;
 - Principle 5 the effective abolition of child labour;
 - Principle 6 the elimination of discrimination in respect of employment and occupation.
- ENVIRONMENT
 - Principle 7 Businesses are asked to support a precautionary approach to environmental challenges;
 - Principle 8 undertake initiatives to promote greater environmental responsibility;
 - Principle 9 encourage the development and diffusion of environmentally friendly technologies.
- ANTI-CORRUPTION
 - Principle 10 Businesses should work against corruption in all its forms, including extortion and bribery.

Thirdly, our main stakeholders are the general public, partners, and donors (mostly, public administrations and firms).

In the last two years we have informed about our commitment in several channels, such as press notes, web site, and social networks:

In addition to that, we have introduced principles related to human rights, labour, and anti-corruption in some agreements of collaboration with partners.

Lastly, we have promoted projects aimed at fostering reusing of sport shoes in Lanzarote, in collaboration with the public institutions, providing a second life for a pair of shoes in Africa.

We are aware that we are just in the beginning of promoting these 10 principles and will continue to do so as we expressed in our first commitment statement.
