Dessemination

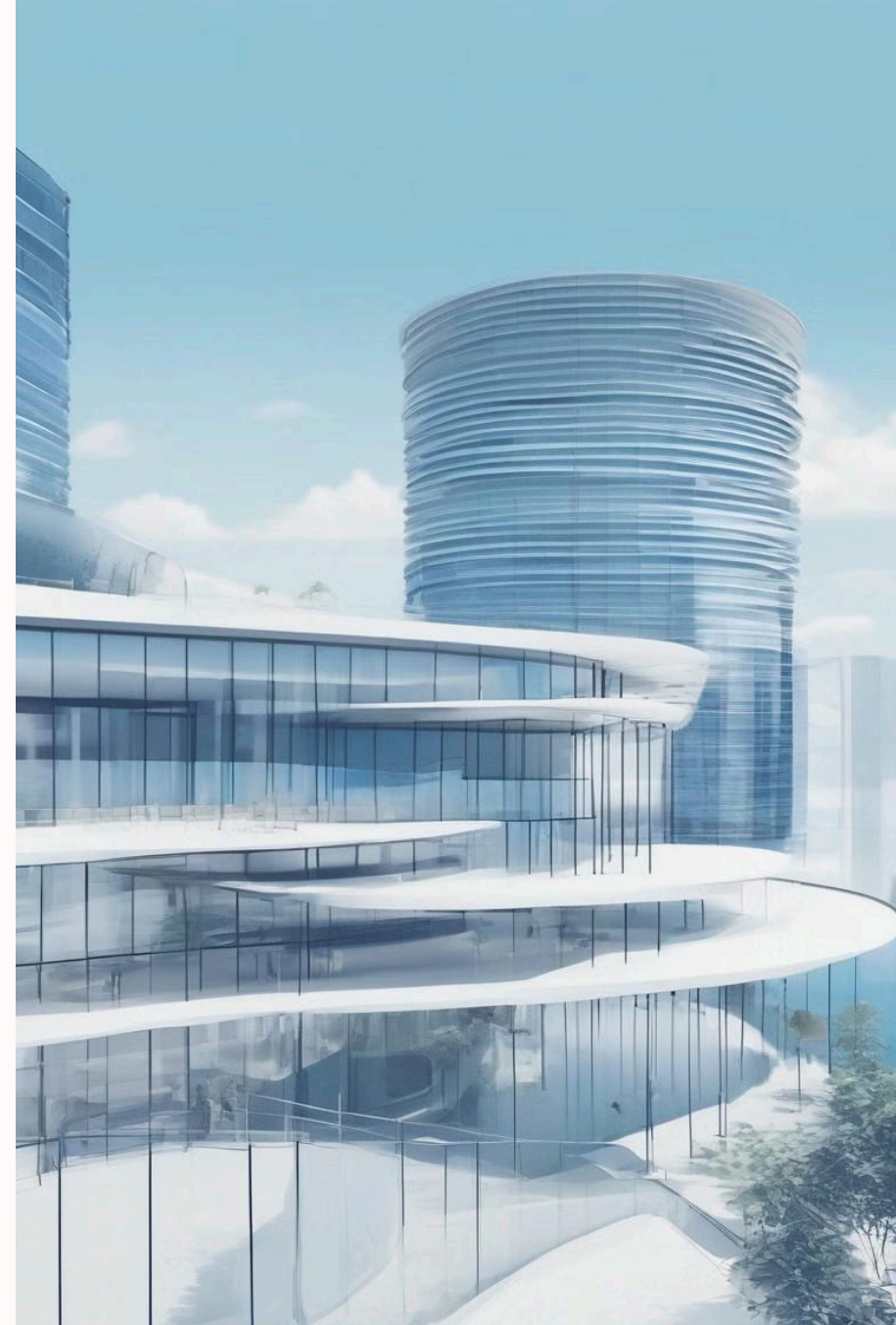
Transparently disseminate our progress and achievements through the Communication on Engagement (COE) process, promoting accountability and transparency.
