To our stakeholders:

I am pleased to confirm that the Markkula Center for Applied Ethics at Santa Clara University reaffirms its support to the United Nations Global Compact and its Ten Principles in the areas of Human Rights, Labor, Environment, and Anti-Corruption. This is our Communication on Engagement with the United Nations Global Compact. We welcome feedback on its contents.

In this Communication of Engagement, we describe the actions that our organization has taken to support the UN Global Compact and its Principles as suggested for an organization like ours. As reported in 2021, we continue to experience a substantial increase in direct engagement with corporations, both those in the Global Compact and others. Due to the nature of the work we do, most of these engagements occur under nondisclosure agreements which prevent our ability to share the specifics. The growth in interest in technology and technology-related issues noted in our last report continues, and is reflected in the scope of our activities during this reporting period. Our ethics professionals have responded to this increase in demand for efforts to support ethical business practices by addressing the development of the responsible use of technology in all of our program areas, which has continued to heighten our interactions with the business sector across the Center's activities.

In addition to the work we do with companies, our engagement in more traditional aspects of higher education has also continued and grown. In this report, we include some of the work of the students who participate in various fellowships at the Center, in partnership with Center ethics professionals on staff.

Our work remains complementary and supportive of the UNGC's 10 core principles, addressing the critical issues of human rights, labor policy, environmental protection, and global corruption, among others. Part II. Description of Actions

The Center has reviewed its primary intellectual property, its Framework for Ethical Decision
Making, and issued a significant revision during this reporting period. The revised framework is now available on the Center's website and through our updated materials. It incorporates a sixth lens, Care Ethics, in addition to the original five lens, to provide a more comprehensive tool for decision making and better reflect global perspectives.

In the past three years, the Center has continued to offer Ethics Spotlights, providing in-depth analysis of ethical issues from a multi-disciplinary perspective, engaging the Center's staff and faculty scholars, and occasional guest contributors. Each of the spotlights touched on at least one of the 17 Sustainable Development Goals.

The Center continues to adhere to guidelines outlined by the national Standards for Excellence programs, following best practices and procedures for nonprofits in the areas of mission, strategy, and evaluation; leadership, board, staff, and volunteers; legal compliance and ethics; finance and operations; resource development; and public awareness, engagement, and advocacy. These best practices align with and uphold the 10 Principles and ensure that the Center is promoting the Principles in its internal operations.

Further, the Center has sustained its own commitment to anti-discrimination practices. During the 2023-2024 academic year, the center embarked on several initiatives in this area. One was an internal diversity analysis of the ethics councils associated with each of the Center's program areas. The other is an ongoing website content audit to ensure the materials presented on the Center's website are welcoming and inclusive of the global audience it reaches.

- Promote the GC and its principles through one of the following activities
 - Deliver education on topics related to the Global Compact:

The Center hosted 14 programs in the reporting period focused on the ethical impact of AI, which relates to Principles 1, 2, 3, 6, 7, 8, and 9. Several of these had overlapping themes related to human rights, labor, or the environment, such as "Being Human at the Age of AI" and "What do Jesuit Values have to do with tech companies?"

We continued programs about democracy, free speech, and civil discourse, relating to Principles 1, 2, and 6; such as, "Ethics and Misinformation" and, "How Might Journalism Help Democracy" and, "Amanda Ripley: High Conflict," and touched on anti-discrimination, in support of Principle 6, with programs like, "Ethical Storytelling."

Ann Skeet, Markkula Center senior director of leadership ethics, facilitated sessions on ethics in two on-going programs training people to serve on corporate boards, through the Silicon Valley Executive Center's Women's Corporate Board Readiness and Black Corporate Board Readiness, both aimed at developing and training a diverse pool of candidates to serve on corporate boards. Her sessions in these programs touch on materials in support of Principles 1, 2, 6, 7, 8, and 10 with an emphasis on corporate ethics and compliance programs.

Together with Dr. Brian Green, Markkula Center director of technology ethics, Skeet presented on the topic of Al Ethics to two corporate boards of global companies, in September and October 2023. They also presented, "Ethics in the Age of Disruptive Technologies" to Amici Lovaniensis, affiliates of KU Leuven, a university in Belgium, in October 2023.

Dr. Green also presented "A Framework for Ethical Decision Making," to the board of the Metropolitan Water District of Southern California in June 2023.

Dr. Green teaches AI ethics in the University's Graduate School of Engineering, where he touches on matters of labor, sustainability and the environment, and anti-corruption.

Dr. David DeCosse, Markkula Center director of Catholic and religious ethics, covers human rights in the three courses he teaches for the University's religious studies department: Ethics of War and Peace, Christianity and Politics, and Conscience, Christianity, and Politics.

 Decades of overuse and climate change have exacerbated droughts and water shortages around the world, and Indigenous groups are disproportionately feeling the resulting effects of water insecurity.

- Conduct applied research and thought leadership in relation to the Global Compact:

The Markkula Center convened a group of distinguished experts to discuss the implications and challenges of AI regulations with the Honorable Ro Khanna in March 2024. The roundtable discussion was moderated by Ann Skeet.

Dr. Brian Green is working group member of the World Economic Forum's Al Governance Alliance, Resilient Governance and Regulation. His working group published a report, "Generative Al Governance: Shaping a Global Collective Future" in January 2024.

In December 2023, the Center released it's report "Ethics in the Age of AI," outlining how Americans feel about artificial intelligence from an ethical standpoint. The data was derived from a survey of 3,000 respondents age 18 and older, commissioned by the Markkula Center and its Institute for Technology, Ethics, and Culture.

In June 2023 the Markkula Center published Ethics in the Age of Disruptive
Technologies: An Operational Roadmap. Two of the three co-authors, Brian Green and Ann Skeet, are on the Markkula Center staff. The book details how organizations can integrate ethics into the responsible development of technology, and touches on matters of human rights, labor, and the environment. Of particular relevance are the principles
outlined in the book. The book drew on research conducted in collaboration with the World Economic Forum, on the experiences of Markkula Center staff consulting directly to companies, and on primary research Skeet conducted about how ethics becomes pervasive in organizations.

In December 2023, Brian Green and David DeCosse, both of the Markkula Center staff, were among the contributing authors of <u>Encountering AI: Ethical and Anthropological</u> <u>Investigations</u>, an exploration of AI that touched on matters of human rights and labor.

· Join and/or Propose partnership projects on corporate sustainability

The center maintains its participation in the Partnership on Artificial Intelligence to Benefit People and Society, where we have been a member since 2017 and several Markkula Center staff participate in the organization's working groups.

The center has also continued to be active in the World Economic Forum's Centre for the 4th Industrial Revolution. Dr. Brian Green is a current member of the Al Governance Alliance. The steering committee for the Alliance includes members from Global Compact companies Bain and Company, Meta, Microsoft, Qualcomm, and Salesforce.

Engage companies in Global Compact-related issues:

The above programs, events, and research engage companies on the issues related to the 10 Global Compact Principles.

Additionally, the Center has a business ethics internship program that connects Santa Clara University undergraduate students with experiential learning opportunities in Silicon Valley businesses, which helps to expose students to ethical dilemmas in the workplace. This helps create awareness of human and labor rights, corporate obligations to the environment and anti-corruption efforts in business early in their careers. Over the period covered by this report, interns have been placed at UNGC members Intel and Marvell and also at Adobe, KLA Tencor, and Cadence.

The Markkula Center has continued to engage with companies one-on-one to help them with matters of ethics. This has included everything from training on using ethics in the development of new technologies and products, assessing culture to ensure labor rights are protected and to prevent workplace discrimination, joining or advising corporate ethics councils focused on tech ethics and anti-corruption, training professional services firms who in turn work with their clients to ensure ethics is used in decision making. Since our last report, we have counseled 24 organizations.

Join and/or support special initiatives and work streams:

As mentioned previously, we continue our membership in the Partnership on AI and our strategic partnership with the World Economic Forum's Centre for the 4th Industrial revolution.

Additionally, we have collaborated on several initiatives with the Centre for Digital Culture of the Dicastery on Culture and Education of the Holy See. The centerpiece of our collaboration with the Vatican is the creation of the <u>Institute for Technology</u>, <u>Ethics</u>, <u>and Culture</u> (ITEC) at the Markkula Center. The Institute convenes leaders from business, civil society, academia, government, and all faith and belief traditions to promote deeper though on technology's impact on humanity.

The Centre for Digital Culture at the Dicastery on Culture and Education of the Holy See has also convened several AI research groups and one of those groups published the book previously mentioned, <u>Encountering AI: Ethical and Anthropological Investigations</u>. Markkula Center staff David DeCosse, Brian Green, and Ann Skeet have each participated in these groups and DeCosse and Green contributed to the book. The most recent research groups are looking at AI and agency and AI and education.

Part III. Measurement of Outcomes

As noted, the Center reports regularly on its activities, including <u>metrics</u>, on its <u>website</u>. In addition to the <u>annual report</u>, we provide real time information about our work in the media through <u>media mentions</u>, press releases and Center newsletters. Here are a few salient metrics:

- 24 corporations hired the Markkula Center for Applied Ethics for ethics expertise during this 3year period
- 4,250 stories by or quoting Center staff appeared in global media in this 3-year period
- 7.1 million people visited the Center's website during the reporting period for resources on ethics
- 9.9 million minutes of Ethics Center videos were watched over the last three years on YouTube
- 3,260 downloads of "Ethics in the Age of Disruptive Technologies" from our website for free and an additional 100 copies sold on Amazon since June 2023

- 1,096,121 views of the Theranos case on YouTube occurred during this 3-year period. The
 <u>Theranos teaching note</u> had 377 downloads during the reporting period. The <u>Theranos page</u> on
 the Markkula Center website had 24,651 page views from 18,744 unique visitors
- The <u>IKEA Case: One Company's Fight to End Child Labor</u> was viewed 33,551 times by 21,731 unique visitors
- Crisis Data: An Ethics Case Study was viewed 12,059 times by 6,670 unique visitors
- <u>Automation and Accountability: An Ethics Case Study</u> was viewed 4,769 times by 2,962 unique visitors
- Emotion Recognition and Smart Cities was viewed 1,942 times by 1,442 unique visitors

Between July 2021 and June 2024, the Center held 43 educational events. Of these, 14 were programs on the ethical impact of AI and other technologies, 6 on democracy, free speech, and civil discourse, 5 on human rights, 2 programs on diversity, anti-discrimination and labor,1 on anti-corruption, and 1 on the environment. Of the programs that explore the ethical impact of AI and other technologies, matters of anti-discrimination, labor, and human rights were also touched on. In addition to the programs listed below, we also did 12 programs related to the Covid-19 vaccines which also included matters of anti-discrimination, labor, and human rights.
