# Description of the King Khalid Foundation's Actions

Established in 2001, the King Khalid Foundation (KKF) is a royal, independent, national institution with a vision for a thriving society with equal opportunities in a sustainable environment. We aim to achieve our vision by empowering the community and providing its members with tools to attain sustainability by mobilizing our stakeholders in three program focus areas:

#### Social Investment

Providing financial support to innovative nonprofit projects and organizations that support skills development, employment, and job creation that benefit the wider community.

### **Capacity Building**

Empowering nonprofit organizations and companies to deliver sustainable social and economic change through studies, consultancy, and training programs that develop the practices and knowledge necessary to create sustainable and strategically focused organizations.

## **Policy and Advocacy**

Advocating for the economic empowerment of Saudi citizens by using an evidence-led approach to design policy solutions that contribute to building an effective social protection system and that bring a fresh perspective to complex social challenges

#### King Khalid Award

The Award has been designed to be an effective and comprehensive change and development tool that focuses on honoring social initiatives, innovative non-profit organizations, and private sector sustainability leaders in the Kingdom of Saudi Arabia.

# KKF and the UNGC

# 1 King Khalid Sustainability Award

Established in 2008, the King Khalid Sustainability Award is a notable part of the prestigious King Khalid Awards (KKA). At the King Khalid Foundation (KKF), our mission is to promote equitable economic growth that benefits society and preserves the environment. To align business practices with sustainable principles, KKF created the KKA Program, which honors organizations that exemplify these values. Importantly, the program prioritizes performance development, offering support to organizations of all sizes, industries, and maturity levels as they address environmental challenges and contribute positively to their communities. Today, the KKA Program is widely recognized as one of the foremost initiatives of its kind within the Kingdom and broader GCC region.

The King Khalid Sustainability Award is designed to enhance the private sectors competitive advantage by advancing environmental, social, and governance (ESG) performance, and has seen correlated performance improvement across the Kingdom's private sector companies across its 16 Award cycles since its establishment. KKF works in close partnership with the Saudi Stock Exchange and the Ministry of Commerce to support the integration of sustainability reporting and disclosures, with the goal of making these practices mandatory.



In addition, the Award serves as a platform for organizations to elevate the quality of their sustainability reporting, ensuring alignment with both international and local frameworks and standards, such as the Sustainable Development Goals (SDGs), Global Reporting Initiative (GRI) Standards, and the Sustainability Accounting Standards Board (SASB). The Sustainability Award also actively monitors the latest developments in corporate ESG standards and disclosures, including the International Sustainability Standards Board (ISSB), Task Force on Climate-related Financial Disclosures (TCFD), Science Based Targets Initiative (SBTi), and emerging nature-based frameworks and standards.

KKF is proud to lead the way in advancing corporate responsibility by engaging and empowering key stakeholders throughout the Kingdom of Saudi Arabia.

Each Award cycle, the top three winning organizations are honored at the Award Gala, which will be held under the patronage of the Custodian of the Two Holy Mosques, King Salman bin Abdulaziz. The Award centers around three core areas that are vital to a robust corporate sustainability program:









# Empower and Enhance Corporate Performance

Foster a deeper understanding of the economic and innovative advantages of responsible business practices by integrating social, environmental, and governance considerations into core management decisions.

# Performance Development

Emphasize capacity building, skill enhancement, and the sharing of best practices to foster a culture of quality and continuous learning.

# Strengthen National Competitiveness and Long-Term Prosperity

Promote improvements at the company level to enhance Saudi Arabia's global competitiveness, support the long-term prosperity of local businesses, and recognize excellence in sustainable and responsible practices.

# Encourage Innovative Sustainability Practices

Promote and strengthen innovative sustainability practices within businesses, empowering local networks of leading practitioners.





# **Award Application Process**

Participants receive comprehensive instructions, guides, and resources to assist them throughout the application process.

#### **Outreach Efforts**

A variety of outreach methods, including workshops, webinars, presentations, emails, social media, websites, text messages, and other media channels, are employed to engage and inform participants.

## Performance Development Workshops

In-person workshops and webinars are conducted to enhance participants understanding of ESG and sustainability best practices in Saudi Arabia and globally. These sessions encourage interaction through engaging activities and discussions, effectively preparing participants for the award cycle.

## Scorecards

Participants receive overall performance evaluations and detailed feedback on each criterion of the Awards process, including specific areas for improvement, based on best practices.

#### **Discussion Sessions**

Individual consultation sessions are offered to review scorecards, providing participants with a deeper understanding of the recommendations and feedback received.

#### Attend the Award Gala

All participants are invited to the King Khalid Award Gala, held under the patronage of the Custodian of the Two Holy Mosques, King Salman bin Abdulaziz, offering valuable networking opportunities for companies.



# **Social Investment Program**

Within KKF's Social Investment Program, the **«Green Opportunities Grant»** is a grant that aims to provide financial and technical support for NPOs with initiatives that create Green Job opportunities for vulnerable groups in society. It seeks to fund programs that have positive and sustainable impacts on the environment.

**«The Social Entrepreneurship Grant»** is another grant offered by the program, which provides entrepreneurs with technical and financial support to develop innovative solutions that support the environment and the circular economy. The grant aims to transform their initiatives into fully-fledged enterprises through incubation or acceleration programs.

1. The policy design and advocacy program in King Khalid Foundation works on several projects and campaigns, raising awareness of climate action and the SDGs in promoting mitigation, adaptation, and sustainable development, such as:

## **Developmental Dialogues**

A platform where policymakers and experts from all sectors come together to discuss socio-economic challenges. Our latest development dialogues around corporate sustainability opportunities are in (Construction and water)



An interactive experience that includes different Eco-games to level up sustainability practices in daily activities for individuals, especially youth. The maze consists of 4 games under 3 major themes (People, plants, prosperity). The players will learn about their environmental impact using Augmented reality.





**2.** This year, the King Khalid Foundation introduced a Learning Management System (LMS) named **«Medad»** to enhance awareness, improve performance in adopting sustainability practices, and build organizational capacity through customized online training courses.

Medad provides courses aimed at providing Saudi organizations with a foundational understanding of Environmental, Social, and Governance (ESG) topics, thereby supporting them in advancing their sustainability initiatives.



# Measurement of Outcomes

KKF uses Logical Frameworks to measure and monitor the outcomes of its programs and projects, sets KPIs for each program, and monitors progress quarterly. In 2021, KKF engaged an independent agency to measure the impact of its programs and SROI as a first step in the strategy review and preparation of the next strategy cycle.

The impact assessment of KKF's programs shows that overall, many core and end beneficiaries of have successfully achieved their goals after participating in our programs and that they have improved their skills and related outcomes. Most beneficiaries reported that the learnings and practices gained were implemented for

# 3-6 months (40%) or 1-2 years (32%)

However, end beneficiaries reported that new learnings were sustained for slightly longer:

39% sustained them for 3 years or more and 21% for 1-2 years.



The King Khalid Awards also led to some unintended positive impacts, including empowering beneficiaries and increasing their self-esteem, the dissemination of beneficiaries' newly acquired skills with others outside their organizations through consultations, and the launch of an Environmental, Social, and Governance (ESG) disclosure guidelines by Tadawul after their partnership with KKF.

The King Khalid Foundation will conduct regular evaluations of its programs and projects to assess their Social Return on Investment (SROI) and ensure continuous progress and effectiveness. This ongoing assessment will allow the Foundation to maximize benefits, identify areas for enhancement, and formulate strategies and initiatives that advance our mission of fostering sustainable growth and driving positive change.
