the "Chamber Orchestra Mannheim - UNESCO City of Music" is a renowned classical orchestra with a tradition of more than 60 years. Its 14 selected international musicians together with its organization of business and management administration as well as its constituency and furthermore its friends-association maintains the important tradition of the so called "Mannheim-School", playing a crucial role within the entire musicology. Being home-based in the City of Mannheim, Germany - officially an UNESCO City of Music - the orchestra does not only perform its regular regional classical concerts, but also is booked for more than 90 shows all over Germany, all over Europe per year. While maintaining classical music tradition each of the members of the orchestra and its administration at the same time clearly recognizes and understands not only its responsibility for societal and environmental issues, but also its capability and outreach in order to spread the gospel of the values reflected within the 10 UN Global Compact principles. Based on this self-conception the Chamber Orchestra Mannheim as a non-profit civil society organization supports a variety of public sustainable development initiatives.
