We acknowledge that the key requirement of participating in Global Compact is to present the "COP" about the detailed information of carrying out the ten principles. We support public liability and principle


of transparency. Therefore, we will commit to the progress report which is consistent with the Global Compact COP policy one year after we participate in Global Compact and every year after. It includes:
