# The Origin Story:

Family Mask was born to address the critical storage of surgical grade PPE for not only frontline healthcare workers, but also for other segments of our global community providing care to at-risk and marginalised groups.

Family Mask is the first surgical mask manufacturer in Asia which is FDA-approved and ISO-certified which is distributing surgical masks to all corners of the world, covering all quantities of need, through an e-commerce (B2B2C) portal.

So far, the social impact work of Family Mask has seen more than 400,000 surgical masks donated across Asia, North America, Middle East and Africa, with more regions coming onboard soon.

High Quality Raw Materials: Using the latest non-woven fabric, Family Mask is a rare 3-ply product which can afford such high Bacterial and Particle Filtration Efficiency levels exceeding 99%.
