
I am pleased to confirm that **MGG S.r.l.** supports the Ten Principles of the United Nations Global Compact on human rights, labour, environment and anti- corruption.

- A measurement of outcomes (i.e., the degree to which targets/performance indicators were met, or other qualitative or quantitative measurements of results).
