Dear Mr. Secretary-General,

I am pleased to confirm that Nuseed Nutritional US Inc. ("Nuseed Nutritional") supports the Ten Principles of the United Nations Global Compact on human rights, labor, environment and anti-corruption. With this communication, we express our intent to adhere to these principles. We are committed to making the UN Global Compact and its principles part of the strategy, culture, and day-to-day operations of our organization, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals.

- A measurement of outcomes (i.e., the degree to which targets/performance indicators were met, or other qualitative or quantitative measurements of results).
