First as part of the thyssenkrupp group and, since August 2020 as stand-alone company, TK Elevator GmbH has a longstanding commitment to the Ten Principles of the United Nations Global Compact on human rights, labour, environment and anti-corruption.

At TK Elevator we are committed to making the UN Global Compact and its principles part of the strategy, culture and day-to-day operations of our company, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals.

TK Elevator has made a clear statement of this commitment to our stakeholders and the public in its Code of Conduct (available at https://www.thyssenkrupp-elevator.com/en/company/compliance/code-of-conduct/) and my express commitment, together with the other members of the management board, against corruption and anticompetitive practice, with a clear zero tolerance policy in this regard.

Further, TK Elevator has publicly committed to Sustainability by reducing the environmental footprint of our products, processes and operations. In particular, we have committed to fewer CO2 emissions, increased energy efficiency and work hard towards reduced water consumption as well as improved waste management. Specifically, by 2030, TK Elevator is targeting a carbon footprint reduction of 25%, and by 2040, the company is aiming to reduce its GHG emissions by 50%, based on its current carbon-footprint for Scope 1 and 2 emissions.
