Established 2008, YONER-LIBERIA is a legal business youth organization committed to the vision of assisting youth develop a sense of self-esteem and moral integrity for future leadership roles in society through business empowerment initiatives.

Over the years, YONER-LIBERIA has endeavored to achieve this vision through the provision of direct job and employment opportunity for youthful population especially so giving prolong exposure to a culture of violence as attended to by the 14 years civil war in Liberia. For this reason, it has embarked in reversing the trend through its Youth Sustainable Waste Management Business Assistant Project funded by CHF-International and in the employment of several other institutions.

YONER-LIBERIA has been involved with Primary Waste Collection from households, and small businesses, buying and selling of Recyclables and production of Compost from organic waste/fertilizer over a period of approximately two years in Paynesville City precisely the Duport Road and Paynesville City hall communities. This initiative has been implemented with the financial and technical support of CHF-international/Liberia under its YES PROGRAM funded by Bill and Medina Gates Foundations to empower urban youth and community-based organizations throughout post-war Liberia.

The organization is currently involved with the followings; selling of Fertilizers produced from organic wastes and buying and selling of recyclables materials as well as community services which include primary waste collection. In the next one to two years period the organization anticipates to extend from the three existing community in which it operates to approximately 25% to 30% of the Paynesville City.

The major trigger of our expansion is that the organization needs monetary and non-monetary assistance (equipment and supplies for office, administrative cost, field works, Technical and mentoring services). And it is necessary because without the availability of money and needed equipment/supplies the organization will not achieve its planned activities in the waste business.

As YONER-LIBERIA envisages carrying out a successful business, provide an equitable and attractive compensation package to its employee and render good services to its customers and partners, the mentioned amount would make a significance changes in its operations and to be amongst the potential waste competitors in Liberia.
