The company has 215 employees, who jointly conduct sales totaling approximately SEK 670 000 000. Our customers include private industry, major Swedish property companies and public administration services. Our operations are primarily conducted in western Skåne from our three offices in Arlöv (Malmö), Landskrona and Helsingborg. In 2004 we were certified within ISO 9001, ISO 14001 and now we also have a system build on OHSAS 18001 and our integrated system involves the Global Compact. We have also got a Code of Conduct that involves the Global Compact.



With this communication, we express our intent to advance those principles within our sphere of influence. We are committed to making the Global Compact and its principles part of the strategy, culture and day-to-day operations of our company, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Millennium Development Goals.
