Dear Mr. Secretary-General,

China Federation of Overseas Chinese Entrepreneurs, approved by the Chinese State Council and registered in the Chinese Ministry of Civil Affairs, is a non-profit national organization which is directed by the All-China Federation of Returned Overseas and is the biggest federation of overseas Chinese entrepreneurs. We have more than 11,000 corporation members involving returned Chinese, returned overseas students, citizens from Hong Kong. Macau and Taiwan, all overseas relative and their companies. Our members distribute in China mainland and other 20 countries or areas, and their investments cover almost all business fields. What's more, we have being made close contact with more than 200 mainly important Chinese organizations distributed in more than 100 countries or areas.

Aim of our organization: 'serving our members and contributing to the society'.
