Prepares a Letter of Commitment (Fig. 1 below) signed by the Chief Executive Officer to the Secretary-General of the United Nations expressing commitment to

- the Global Compact and its ten principles; and
- participation in the activities of the initiative where feasible.

Requirements of the Letter of Commitment for non-business organizations

- 1) The letter contains an official company letterhead;
- 2) The letter is addressed to the UN Secretary-General;
- 3-4) The Statement includes the organization's support for the ten principles of the Global Compact and to take part in the activities of the initiative;
- 5) The letter is signed by company's highest executive or equivalent (name and title must be legibly printed underneath the signature);
- 6) The letter (one-page statement) is scanned and available for upload before completing the Online Registration Form.

Completes the Online Application Form (Fig. 2a-2b below) and uploads a digital copy of the Letter of Commitment signed by the highest executive;

To complete online application form you will need:

- To ensure that your Letter of Commitment fulfill the requirements stated above.
- The name of the company's chief executive who signed the Letter of Commitment must correspond with the entry in the online registration form.
