Dear Mr. Secretary-General,

I am pleased to confirm that RTI (TRK Interradio Ltd.) supports the ten principles of the Global Compact on human rights, labour, environment and anti-corruption. With this communication, we express our intent to implement those principles. We are committed to making the Global Compact and its principles part of the strategy, culture and day-to-day operations of our company, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals. RTI (TRK Interradio Ltd.) will make a clear statement of this commitment to our stakeholders and the general public.

We recognize that a key requirement for participation in the Global Compact is the annual submission of a Communication on Progress (COP) that describes our company's efforts to implement the ten principles. We support public accountability and transparency, and therefore commit to report on progress within one year of joining the Global Compact, and annually thereafter according to the Global Compact COP policy.

Our company is willing to be closer to the world community and support global values such as freedom of speech, employee's rights equality, comfortable working conditions of high quality. We would like to join UN Global Compact and be a part of global association that would enable us to implement the main principles aimed to protect human rights and improving human's life in the best way.

Broadcasting company RTI (TRK Interradio Ltd.) is constantly improving its conditions in human rights area, labor rights, environment protection and anti-corruption. We use all these principles in our daily work:

Principle N2 (Human rights). All the employees of our company are officially registered and being paid an official salary. The employees are working in accordance to the labor code (with no exaggerating the working hours limit (40 hours per week). We also support CSR policy.

Principle 7-9 (Environment). We give a special attention to ecology protection and innovations aimed to preserve natural resources. We have special boxes in our office for the used paper that we send for recycling.

Principle 10 (Anti-corruption). There is a large number of programs we are broadcasting with the aim to fight the corruption and show the political, social and economic problems and issues in current Ukrainian life. We invite famous Ukrainian politicians, political scientists and experts in social and economic life to the programs to talk different issues.

We also collaborate with Ukrainian UN' representative (we are broadcasting the video of the representative's press center and we invite the speakers to our programs).
