Reference is made to the United Nations Global Compact to encourage corporate consideration of universally-accepted principles to harmonize the role of business and society.


The Global Compact recognizes that, because of the wealth that business creates, businesses are part of the solution to world peace and security and a decent standard of living and quality of life.
